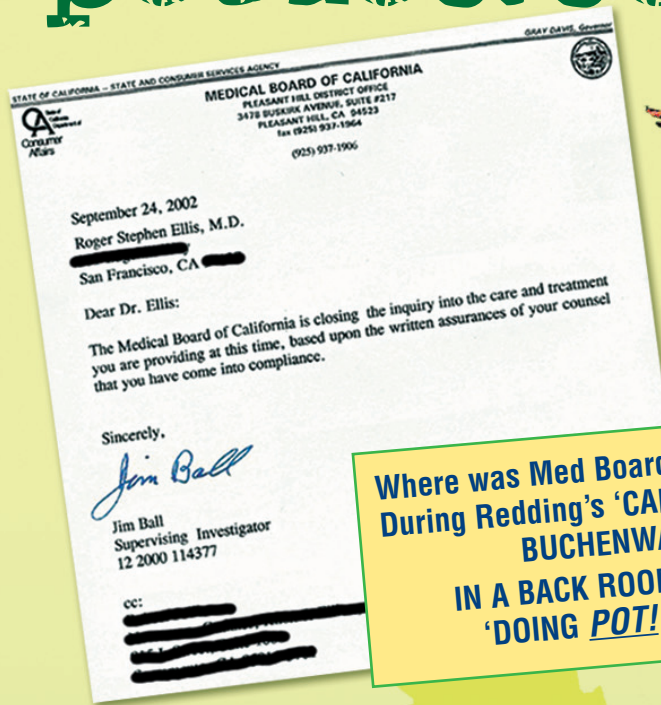
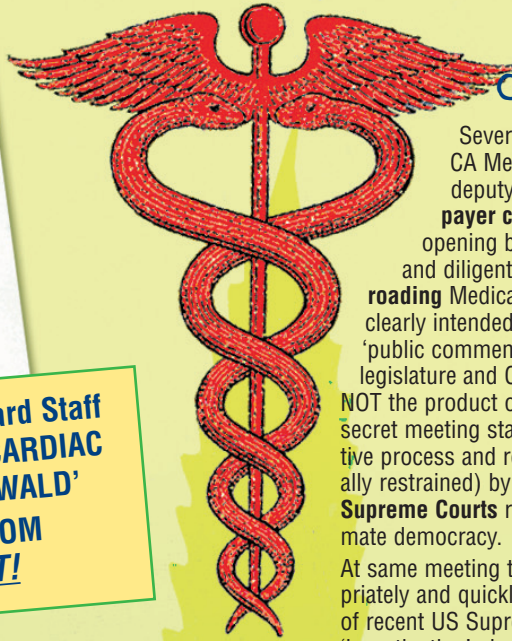

Where was Med Board Staff

Several Cannabinoid Physicians, patients, and Prop 215 leaders attended the CA Medical Board meeting 7 May'04 in Newport Beach.
