BOTH all these 'aiding and abetting' Physicians **and** their CRIMINAL PIMPS (&JDs!) involved in these '**UNLICENSED PRACTICE of MEDICINE**' scams face a 'strikes-counting' full 1 year in State PRISON, in addition to PERMANENT MD license REVOCATION. MDs stupidly facilitating fraudulent Med Board 'clinic' registrations face even MUCH worse, and need IMMEDIATE Med Board CRIMINAL Law assistance in turning proof-of-good-faith State's Evidence as their **ONLY** realistic hope of escaping prolonged State Prison themselves. The Board traditionally has taken a VERY aggressive & hostile view of these fraudulent medical scams, and indeed has implemented a MAJOR new special 'Operation Safe Medicine' pet project specifically to deal with these CRIMINALS. Penalties are currently being even more tightened (see Med Board Minutes). Clearly, they are not amused with 'stoner games' especially including hoax 'Management Company' joke ownerships. As per the Medical Board, if the 'management company' has ever or does advertise for clinic physician staffing (web, Craig's List, or wherever) or retains control/ownership of medical records/patient identities they are BY DEFINITION just a bogus CRIMINAL hoax. FURTHERMORE : **ONLY** a mere ~1/4 ! (12 out of 41) Northern CA Cannabis Physicians are even in token compliance with the Medical Board's published Medical Marijuana diagnosis confirmation requirements. ALL legally valid Cannabis recommendations MUST have supporting documentation to be able to withstand challenge in Court – either patient provides such; or MD orders appropriate tests, etc, themselves; or just sends the patient out for work-up; for **both** the physician and the patient to be in legal compliance.
